



Participation and Release Form

In consideration of being registered as an official participant in the 2020 Korzeti Sportverseny program (the „Program”) organized by the New York District of the Hungarian Scout Association in Exteris (herein the „HSAiE”), the undersigned agrees and consents to the following:

1. He/she wishes to participate in the program (in the case of participants under the age of eighteen (18), the undersigned parent or guardian hereby additionally permits his/her child to participate in the Program).

2. The participant (and, as appropriate, parent or guardian) has read, understands and accepts the Program rules and agrees to abide by same in all respects. The undersigned shall report the results of the participant’s participation in the Program honestly, in the spirit of scouting and fairness.

3. Participants who are minors will only engage in specific Program activities (a) with the permission of their parents or guardians, and (b) while being actively supervised by a parent or guardian.

4. While participating in Program activities, the participant (and, as relevant, the parent or guardian) will abide by and follow all applicable local, state and federal rules relating to the on-going coronavirus pandemic, including, without limitation, all restrictions or limitations on indoor and outdoor activities and any and all social distancing and face covering guidelines that may be in effect. It is agreed and understood that the Program is based exclusively on individual participation and activity, consequently the participant shall not engage in any group or multi-person activity that would violate any of the foregoing rules, requirements or restrictions or otherwise place himself/herself or others at increased risk of contracting or spreading the coronavirus.

Each undersigned participant (and, as relevant, parent or guardian) acknowledges that the participant is participating in the Program voluntarily and consequently, the undersigned party or parties assume all risk associated with the participant’s participation in the Program. The undersigned hereby release and shall hold harmless the HSAiE and its leaders, helpers and associates from any and all claims, causes of action and/or damages related to or resulting from the participant’s participation in the Program.

6. If and to the extent the participant or his/her parent or guardian transmits to the HSAiE or any of its leaders photos or videos of the participant participating in the Program (the „Released Subject Matter”), the HSAiE shall have the right to publish such materials on its Instagram account, Facebook page or otherwise. The undersigned hereby gives the HSAiE and its successors, assigns, agents, licensees, affiliates and representatives, or anyone authorized by any of them (collectively referred to herein as the "Releasees") the absolute and unrestrained worldwide right and permission in perpetuity to own, utilize, or alter the Released Subject Matter, in any manner, without limitation, cost and in any language the Releasees may see fit and for any purpose whatsoever (including, without limitation, in connection with the HSAiE’s advertising, publicity, public displays, and exhibitions), in and through all media now known or later invented. The undersigned waives (to the fullest extent he, she or they may lawfully waive) any causes of action in law or equity that the undersigned may have or may hereafter acquire against the Releasees or any of them for libel, slander, invasion of privacy, copyright or trademark violation, moral rights, right of publicity, rights of privacy, or false light arising out of or in connection with the utilization by the Releasees of the Released Subject Matter. The undersigned waives any rights that he, she or they may have to inspect and/or approve any finished product or products or any editorial, advertising, or printed copy or soundtrack featuring any of the Released Subject Matter and further waives any right that the undersigned may have to control or limit the use to which said product, products, copy and/or soundtrack may be applied. Nothing in this Participation and Release Form requires the use of any of the Released Subject Matter by the HSAiE for any purpose. It is the undersigned’s intention that the above-referenced consideration represents the sole compensation that he, she or they are entitled to receive in connection with any and all uses of the Released Subject Matter or the releases set forth in this Section 6 by the
